METHOD OF PAYMENT:

Payment is due in full prior to transfer of remains and services are rendered. We accept American Express, Discover, Master Card, Visa.

DIRECT CREMATION PACKAGE PRICE

Includes the basic services of a funeral director / staff and overhead, transfer of decedent from place of death (within service area), refrigeration for up to 5 days, an alternative container, the actual cremation process, basic urn, pick-up at our local crematory or scattering at sea (unwitnessed), Department of Consumer Affairs and disposition permit fees. We are an At-Need / Direct Cremation provider, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials with or without an outside covering. (The containers we provide are fiberboard) We do not offer viewings or embalming.
